Ishaan Kumar Sandhir has been subject to minor criminal proceedings in the past. Specifically, in late 2017 he was charged in the State of Indiana with the following crimes:

35-48-4-2(a)(2)/F6: Dealing in a Schedule II Controlled Substance

In early 2018, the first charge was dismissed, and the second charge was a guilty plea resulting in a misdemeanor conviction. However, it is important to note that:
