Maikel den Hertog holds a Bachelor of Science in Sociology from Tilburg University in the Netherlands, with minors in Economics and Business Economics. In addition to his formal education, he has engaged in extensive private study in macroeconomics and value investing, drawing from the influential works of Gregory Mankiw, Benjamin Graham, John C. Bogle, David Dodd, Thomas Sowell, Paul Krugman, and Tim Koller. Over the past five years, Mr. Den Hertog has cultivated a diverse and pragmatic professional background.

In May 2024, he became an Investment Advisor Representative at Eagle Investors LLC, where he provides investment education and advisory services. In March 2025, he assumed dual roles as a Supervised Person at Eagle Guardian Advisors LLC, a Texas-based Registered Investment Advisor, and as Managing Partner of Eagle Horizon Ventures LLC, a Wyoming-based private equity firm backed by private capital. Through these positions, Mr. Den Hertog offers portfolio management and financial planning services, while also overseeing the strategic direction and operations of a diversified portfolio of businesses.

All of Mr. Den Hertog's business affiliations operate independently but are unified under common ownership structures. This role is directly related to his activities with the advisory firm.

Managing Partner, Eagle Horizon Ventures LLC (March 2025 – Present): Mr. Den Hertog serves as Managing Partner of Eagle Horizon Ventures LLC, a Wyoming-based private equity firm financed by private capital. The firm manages a portfolio of operating businesses.

Item 6: Supervision
